



Directions to the OCC

The Office of the Ohio Consumers' Counsel is located in downtown Columbus, at 10 West Broad Street, Suite 1800. The building is on the northwest corner of Broad and High streets, diagonal from the State Capitol.

Directions

I-71 southbound toward downtown Columbus

Follow I-71S to the Broad Street exit. Turn right on Broad. Follow Broad Street to Third Street. Turn left on Third Street. Park in the State Capitol underground parking facility on the right side of Third Street; or follow Third Street and turn right on State Street then right on Front Street to enter the Huntington Center or LeVeque parking garage; or follow Third Street and turn right on Rich Street to park in the City Center Garage.

I-71 northbound toward downtown Columbus

Follow I-71N to I-70E to the Fourth Street/Livingston Avenue exit. Follow the exit ramp and turn right onto Fourth Street. To park at the City Center garage, follow Fourth Street and turn left on Rich Street; enter the garage on the left side of Rich Street just past Third Street. To park in the State Capitol underground parking facility, follow Fourth Street to State Street and turn left on State Street; enter the garage on the right side of State Street. Or follow State Street and turn right on Front Street to enter the Huntington Center or LeVeque parking garage.

I-70 westbound toward downtown Columbus

Follow I-70W to the Fourth Street/Livingston Avenue exit. After exiting, go straight through the Third Street traffic light and turn left onto Fourth Street. To park at the City Center garage, follow Fourth Street and turn left on Rich Street; enter the garage on the left side of Rich Street just past Third Street. To park in the State Capitol underground parking facility, follow Fourth Street to State Street and turn left on State Street; enter the garage on the right side of State Street. Or follow State Street and turn right on Front Street to enter the Huntington Center or LeVeque parking garage.

I-70 eastbound toward downtown Columbus

Follow I-70E to the Fourth Street/Livingston Avenue exit. Turn right on Fourth Street. To park at the City Center garage, follow Fourth Street and turn left on Rich Street; enter the garage on the left side of Rich Street just past Third Street. To park in the State Capitol underground parking facility, follow Fourth Street to State Street and turn left on State Street; enter the garage on the right side of State Street. Or follow State Street and turn right on Front Street to enter the Huntington Center or LeVeque parking garage.

Parking Suggestions

City Center Parking Garage

If you park in the City Center Garage you will want to walk through the mall to the High Street exit (by Max and Erma's). Turn right as you exit the building and cross State Street. Walk past the front of the Statehouse to the intersection of Broad and High streets. Ten W. Broad Street is on the northwest corner.

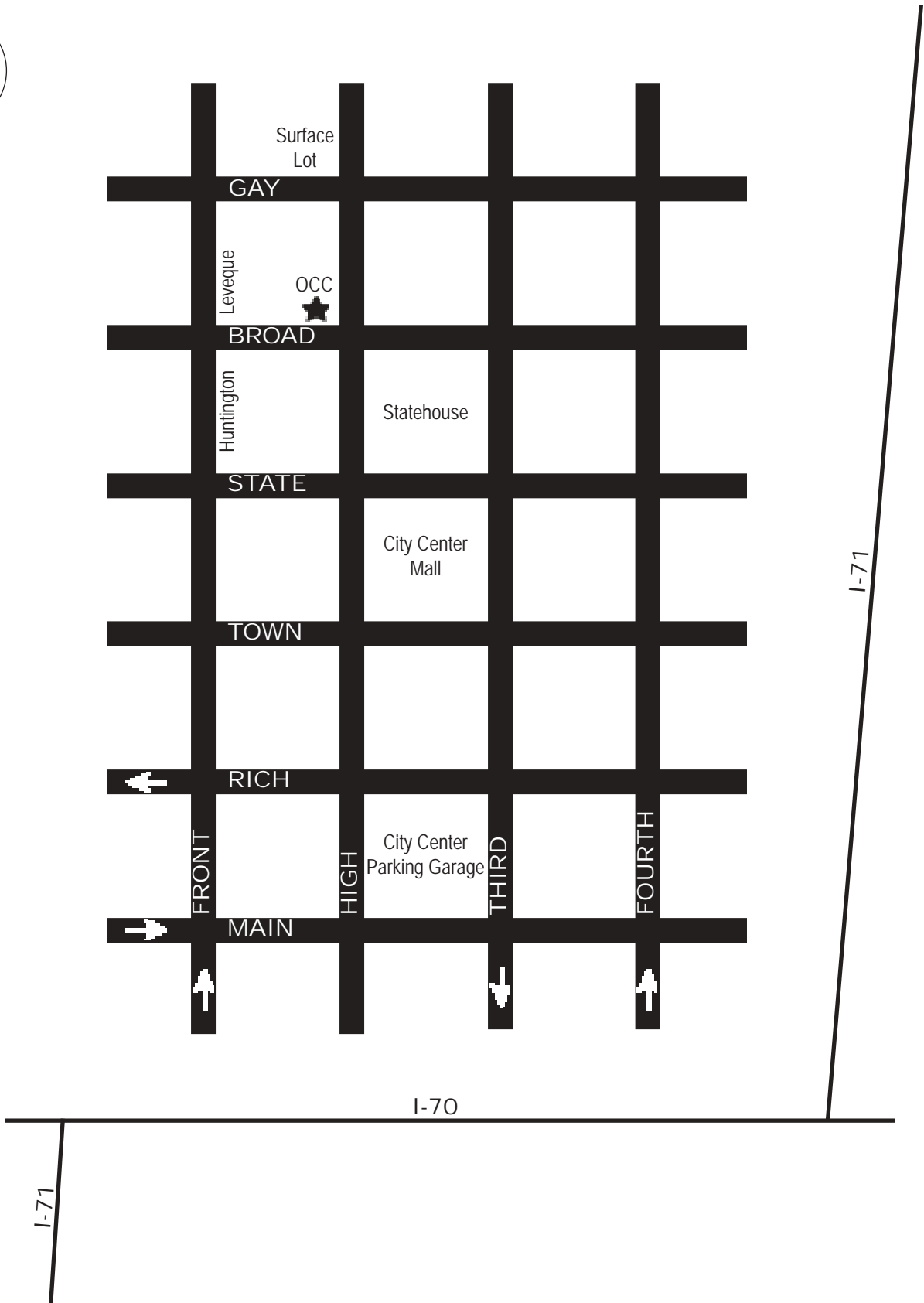
State Capitol Underground Parking

If you park in this underground lot, take the elevator or stairs on the northwest corner of the garage to street level. At the intersection of Broad and High streets, you will see 10 West Broad Street on the northwest corner.

LeVeque Parking Garage

If you park in this garage, go to the second level and take the walkway into the LeVeque Tower. Turn left just past the dry cleaners and continue walking until you reach the vending machines where the hallway takes a left turn. Go through the revolving door and down the escalators and you will be in the 10 W. Broad Street Building.
